## Planning Matters



Gloucestershire County Council will be running a **public consultation for the Aston Fields development on Thursday 18 November in the Town Hall**. There will be a presentation and an exhibition of pre-application plans. Written representations will also be taken. Cotswold District Council has now commented on the **Design Statement for the Neighbourhood Plan**. When these comments have been incorporated by AECOM, the consultants who specialise in Design Statements and are working on this for the Town Council, the revised Neighbourhood Plan will be put out for a wider public consultation. As soon as we have more details about these events, we will let you know. Please do participate, it is an opportunity to be a voice in the shaping of our town.

We are working through the local details of its **Green Infrastructure Strategy** with help of volunteers. This strategy will be used to inform the CDC's partial update of the district's Local Plan - which sets a framework for planning decisions such as how the Council will meet the need for new homes, employment, open spaces, schools and leisure facilities. We will be canvassing local people for their thoughts on Campden's green spaces to include in our appraisal.

The Cotswolds ANOB, the Ramblers Association, and many other walking groups have registered **all footpaths and rights of way across our region** before the Countryside and Rights of Way Act deadline of 2026. Our visitors had fun collecting apples and looking at the identification display. They bought apple juice and had a go at the fabulously successful Longest Apple Peel Competition - including tasty butterfly cakes for entrants - an activity surely now to be the bedrock of every Apple Day hereafter!



**Our Saturday Pick Your Own mornings (every 2nd and 4th Saturday until December)** have gone down a treat with lots of visitors taking home different varieties for eating, cooking and making preserves.

Special thanks this month to **Wade Muggleton** from **The Marcher Network** for his advice. Apple expert and author, Wade has appeared on BBC Gardener's World and he's just published *The Orchard Book*. Wade told us we have some intriguing varieties in the orchard. He helped us name a few of the more common types and, after some research, also identified a number which he hadn't come across before

kindly gave us a Biodiversity Boost grant earlier in the year which helped pay for our new trees and much of our winter maintenance programme. We got a “thumbs up” for all the work we had carried out, and even had time to try a few apples.
