## **Planning Matters**

Cotswold District Local Plan Partial Update. Many of you will remember that the Society and individual members participated in the consultation last year to help CDC partially revise the District's Local Plan. They are now undertaking a further public consultation from Thu 16 Feb to Thu 16 Mar on two evidence documents concerning "Non-Strategic Site Allocations" & "Guidance for Major Developments" in the AONB. As they say "Both consultation documents are unavoidably technical in nature and we are primarily seeking feedback from those with technical expertise, although the consultations are open to anyone who wishes to respond." If you would like to participate these can be found on the CDC website under Planning Policy. The CDC hopes to put their draft Local Plan out for public comment this coming Winter 2023/4 before submitting it to the Planning Inspectorate.

**National Policy consultation.** The government is also consulting on changes to national planning policies, which are part of its wider reforms proposed by the Levelling Up and Regeneration Bill. The proposals would affect the Cotswold District and CDC's response will be up on their website shortly. This consultation is open to everyone and so you can provide a response if you would like to take part. The consultation can be found on the government's website, gov.uk, under: "housing-local-and-community/planning-reform".

Make a Difference There will be Town Council elections this May and the Council are looking for new candidates to join them. Being a Town Councillor can be a varied and highly fulfilling role. Campden Buildings History Register. Chipping Campden and Broad Campden have a high density of old and Historic England Listed buildings. They are an important part of the character, beauty, and significance of our settlement. The history and development of these buildings are documented in many different ways including house deeds; family history records; heritage assessments; planning reports; and the Historic England database. The Campden Society and Chipping Campden History Society are currently developing a project to bring together all the available information so that we can create a profile of each house to help

future historians, architects and owners.
